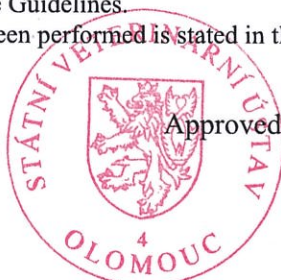

The stated extensive uncertainty is expressed as a  $\pm$  % of the stated value (relative expression of uncertainty) or a  $\pm$  value in parameter units (absolute expression of uncertainty). In the case of an absolute expression of the measured uncertainty, the parameter units are not stated after the uncertain value.

Sampling uncertainty is not reflected in the expanded measurement uncertainty as stated in the test report.

The data marked in the report with an asterisk \* are not covered by the accreditation. The data marked in the report with "+F" refer to the use of flexible scope of accreditation. The data marked in the report with "+A" refer to a change made as part of an update of the Guidelines.
